Board Member Expectations Qualifications and Requirements

President Qualifications: Must have previously held an elected position on the Board of Directors; must be a regular member in good standing, be employed full-time by their agency within the state of Florida, and maintain said employment. Must have the support of their employing agency for a two (2) year commitment to the Florida Gang Investigators Association.

Vice President Qualifications: Must have previously held an elected position on the Board of Directors; must be a regular member in good standing, be employed full-time by their agency within the state of Florida, and maintain said employment. Must have the support of their employing agency for a two (2) year commitment to the Florida Gang Investigators Association.

Regional Director Qualifications: Must have been an active member of the Florida Gang Investigators Association for one (1) year; must be employed full-time within their represented region and maintain said employment. Must have the support of their employing agency for a two (2) year commitment to the Florida Gang Investigators Association.

All Board of Directors members shall attend two (2) annual board meetings, (January and June) and the Annual Training Conference (August). Notice of the time and place of the meetings shall be delivered to each member of the Board of Directors by one of the following methods: (a) by telephone, either directly to the member or to a person at the member's office who would reasonably be expected to communicate that notice promptly to the member; or (b) by e-mail where a read receipt or reply would be generated. All such notices shall be given or sent to the member's e-mail address or telephone number as shown on the Florida Gang Investigators Association records.

Board of Director's Attestation-All Board of Directors must agree and attest that he/she understands and agrees to mandatory participation at Board and/or Committee meetings; including the expectation that the board member has the responsibility of contacting the President or designee if he/she is unable to participate at a scheduled meeting. By signing the attestation, you are also validating that you have read and are familiar with your responsibilities, any/all association requisites, and your commitment to our members.
